Resident Keith Tucker addressed the Board with his concerns of his recently subdivided property "Silo Farm" and acceptance of an offer to purchase all but three acres. It's understood the property will be used to grow cannabis. Many concerns were shared including but not limited to

the assumed use of high concentration of fertilizer, the property is in the Conesus Lake Water Shed, and rat control. He requested the Board consider a ban on growing cannabis. After a lengthy discussion it was noted New York State is the authority to issue licenses to grow. There are currently 4/5 areas approved within Livingston County as well as Ontario County.

Resident Charlie Dickerson addressed the Board requesting no contingencies dollars be included in the contract for siding the building. He questioned if Middle Road is still on the list for cleanup., water meters are the only way to confirm if water leaks are occurring, he shared his church's decision to purchase a copier outright to save money.

Resident Paula Lunn asked if the roof on the cabin was repaired. She will be getting a price for Board consideration to install a foundation to the playground.
