## **DISCUSSION TOWN OF LIVONIA COMMISSIONER AMBULANCE DISTRICT #1**

Supervisor Wester welcomed Commissioner Matt Cicero to address the Town Board and those in attendance with the 2023 Year-End Review of the Town of Livonia Commissioner Ambulance District #1.

Commissioner Cicero shared the following:

- o Every ten years boxes are changed out.
- o 180 mutual calls in 2023
- o 95 percent or greater with first ambulance coverage
- o Revamped quality assurance and quality improvement programs
- Obtained new AED's through grants.
- o Remounted an ambulance saving approximately half the cost of buying new.
- Drastic improvements to winter rehab capabilities provides heated environments to emergency personnel on scenes.
- o Administered CPR saving a life.
- o Delivered a baby.
- o Approximately 1,142 service calls
- o 30 active members
- o 9 members provided over 1000 hours for 71% of all calls.
- o 3 members provided 50% of hours
- o Looking at the affects if a top eight members no longer available to volunteered
- o Insurance was ½ million dollars last year.
- o \$60,000 for Livonia and \$17,000 for Conesus
- o Considering paying volunteers
- o Proposal to paid staffing along with equipment 1.3 million dollars excluding insurance money.

## <u>DISCUSSION TOWN OF LIVONIA COMMISSIONER AMBULANCE DISTRICT #1-</u> continued

- The Town of Livonia has raised tax rates for the last two years without additional tax dollars to the Ambulance.
- o Paid paramedics are being considered for next year.
- o Requesting additional discussions with the Towns of Livonia and Conesus

Supervisor Wester shared an impressive ambulance response to the golf course.

Councilman McCarty stated he was helped a great deal, and their work is appreciated.

Further discussion of the request for financial assistance will be reviewed by the Board at a future meeting.
