Supervisor Wester opened with a moment of silence and Councilman Fama led everyone in the Pledge of Allegiance

#### **PRIVILEGE OF THE FLOOR:**

Supervisor Wester honored Michael Marusiak as one of two Conesus residents to receive the Livingston County Teen Recognition Award for 2024. Supervisor Wester read Michael's accomplishments and presented him with a certificate signed by the Town Board. Emily Foley was the other Conesus recipient, but she was not in attendance tonight.

#### PRIVILEGE OF THE FLOOR (continued):

Heather Ferraro from Livingston County Planning Department, Krista Greer and Angela Gardner from JM Davidson Engineering, D.P.C. presented their findings from a field assessment done on North McMillan Creek.

The town made a streambank repair in 2016, and that repair has begun to fail. Problems and possible solutions were presented. It does come down to what the town and landowner affected are willing to do. It can be looked at as an "a la carte" – the ability to pick and choose options, but at the minimum, the engineers believe that restacking the rocks is basic and necessary maintenance. The NYSDEC does have some stake in it, but it is a Class C Stream – will need a permit from Army Corps of Engineers. Goal is to have permits by year end and have project underway by next "construction season" – spring 2025. These projects are just to stabilize. This stream truly changes dynamically from year to year.

DISCUSSION: It is a long-term project. No work on it will be permanent – it will be a forever ongoing project due to the nature of streams. Concerned citizens who are affected by the stream spoke. Citizens are concerned about their properties eroding and washing away. Livingston County's number one concern at this time is to protect infrastructure – in this case, DaCola Shores Rd. It is up to the property owner to protect and deal with the affects of the stream – it is not the responsibility of the town.

Things to consider: cost to the town, town highway dept. doing the work, cost of materials, etc., concerns of the homeowners, etc.

Thoughts of the town board and highway superintendent...

Dan Marusiak feels if we're going in to do any work, we might as well do the whole project. He does feel the cost is a bit higher than estimated because the town has to have the large stones hauled in and needs to rent a track excavator.

Supervisor Wester – in agreement with Highway Supt. – none of these issues will fix themselves. If we only do part of the project, we may be in a situation again sooner than later.
